
Chapter XXI, Para 21.5.9

Existing Sub Para 21.5.9 of Para 21.5 of Chapter XXI of the SEM Pt.II, 2001 edition may be replaced as under:-

Sub Para 21.5.9	
Existing	Facility of emergency route/sub-route cancellation may be provided, where necessary. Every such cancellation shall be recorded on a counter and in a register to be maintained by traffic representative.
Replaced	Facility of emergency route/sub route cancellation may be provided, where necessary. <u>Where such release is provided, it shall be possible to release the route/sub-route after a delay of minimum 120 seconds.</u> Every such cancellation shall be recorded on counter and in register to be maintained by traffic representative.
