Vide letter under reference (iii) above, PCSTEs were empowered for granting Technical System Application Approval (TSAA) of Electronic Interlocking for all El installations upto 100 routes which was further enhanced to 200 routes vide reference (iv) & (v) above. Policy guidelines were also issued for obtaining TSAA in case of alterations in El vide reference (ii) above.

- 2. Based on RDSO's letter (Ref i above), the criteria for granting TSAA has been reviewed and henceforth, the following will be the guidelines for TSAA:
  - a. PCSTEs are empowered to grant TSAA for all EIs having routes up to or less than 200 routes including alterations thereof till total number of routes surpasses 200, in that case TSAA shall be granted by RDSO.

b. For alterations in Els having more than 200 routes, TSAA shall be granted by PCSTE in case there is no addition to number of CPUs. However, if alteration involves provision of additional CPU, TSAA shall be granted by RDSO.

c. For EI with initial installation case of new vendor/new model on the Zonal Railway, TSAA shall be granted by RDSO.

In reference to above subject, vide letter under reference (i) PCSTEs were empowered for granting TSAA of all EI installations up to 100 routes and vide letter under reference (iii), it has been increased to 200 routes. However, vide letter under reference (ii) for alteration work of EI, it was mentioned that

- (1) For alteration in EIs having more than 100 routes, TSAA may be granted by PCSTE for alteration involved up to 50 routes. For alteration involving above 50 routes. TSAA shall be granted by RDSO.
- (2) For alteration in EIs having less than 100 routes, for any alteration TSAA shall be done at PCSTE's level till total number of routes surpasses 100 routes, in that case TSAA shall be granted by RDSO.

Considering the empowerment of PCSTEs for granting TSAA up to 200 routes, Railway Board, vide this office's letter at ref.-iv, was requested to modify the above criteria of no. of routes for EI alteration work. Railway Board, vide its letter at ref.-v, has modified the guidelines for TSAA as given below:

- (i) PCSTEs are empowered to grant TSAA for all EIs having routes up to or less than 200 routes including alterations thereof.
- (ii) For EIs with initial installation cases of new vendors/new models, TSAA shall be granted by RDSO.

Due to the above modified criteria for TSAA, it is seen that proposals for TSAA are being received in RDSO for even very minor alterations in EI. In most of the cases for which the proposal of TSAA is being received for alteration in existing EI, it is seen that the TSAA has already been given by RDSO when EI was originally commissioned. For giving TSAA, RDSO does the scrutiny of documents which are submitted by the Zonal Railways and all such cases are sent to RDSO after the scrutiny by Zonal Railways

Headquarter and with the approval of PCSTE. TSAA by RDSO was originally mandated when Electronic Interlocking systems were being commissioned initially over Indian Railways and when Zonal Railways were not very experienced in Electronic Interlocking systems. At present, more than 3000 Electronic Interlocking systems have already been commissioned across the Zonal Railways and now the Zonal Railways are very well versed with the Electronic Interlocking systems. Hence TSAA by RDSO is not very much relevant in present scenario and full power for TSAA may be given to Zonal Railways.

Till the time full powers for TSAA is given to Zonal Railways, in cases of alteration in EI having more than 200 routes, it is recommended that TSAA may be given by the PCSTEs for alteration works involving up to 50 routes. For alteration works involving more than 50 routes, TSAA may be given by the PCSTEs if alteration involves changes in only application logic circuits or involving minor hardware changes like I/O boards etc. Accordingly the criteria for granting TSAA may be modified as given below:

- (a) PCSTEs may be empowered to grant TSAA for all EIs having routes up to or less than 200 routes including alterations thereof till total number of routes surpasses 200, in that case TSAA shall be granted by RDSO.
- (b) For alterations in EIs having more than 200 routes, TSAA may be granted by PCSTE for alterations involved up to 50 routes. For alteration works involving more than 50 routes, TSAA may be given by the PCSTEs if alteration involves changes in only application logic circuits or involving minor hardware changes like I/O boards etc. For other alteration works, TSAA shall be granted by RDSO.
- (c) For EIs with initial installation cases of new vendors/new models, TSAA shall be granted by RDSO.

Keeping in view the fact that adequate experience has now been gained by Railway in commissioning of EIs and ABS, it has been decided that:-

"Railways are not required to obtain Technical System Application Approval (TSAA) from RDSO for commissioning of Automatic Block Signalling or Electronic Interlocking installation upto 100 routes. However, for Electronic Interlocking installation with more than 100 routes, the practice of obtaining TSAA from RDSO prior to commissioning will continue."
