Sub: - Approval of Application Logic and Interface Circuits for EI works.

During recent review meeting of projects with CAO/Constructions on 28th Jan 2022, some Railways highlighted approval of signal designs as one of the bottlenecks in timely delivery of projects. The matter has been examined in Board's office and following guidelines in this regard are issued-

- 1. Where Zonal Railways do not have sufficient capacity for design checking and approvals, the zonal railways may enter into contracts with approval of PCSTE / CAO/C for independent checking & verification of application logic and interface circuits through accredited license holders (like IRSE, IRSTELO) before final checking/approval by Railways.
- 2. Alternately, contractors should submit designs after independent checking & verification by accredited license holders (like IRSE, IRSTELO) to Railways for final checking/approval.
