Sub: Track Circuiting on 'D', 'E.Spl', 'E' & MG Routes.

Ref: This office letter of even no. dt. 13.10.2003.

In partial modification to above referred letter, following revised paras are as given below:

# Para 3.0:

## A. BG Routes - 'D', 'E.Spl'. & 'E'

(ii) May be read as under:

"Track Circuiting on E route be limited to only FM-FM and FM-BSL & FM-Home Straight portion. While FM to FM Track Circuiting on E route is already sanctioned, proposals for straight portion track circuiting on 'E' route be submitted for sanction, at stations having permitted speed above 15KMPH in station section."

## B. MG Routes

(ii) Stations where GC is not sanctioned para may be read as under:-

"FM to FM Track Circuiting at such stations, where as per signal interlocking system, permitted speed is more than 15 KMPH, can be provided either by replacing the existing sleepers with MG PRC sleepers or by using Axle Counters. However, stations, where track renewals or casual renewals are already sanctioned, track circuits should be provided using MG PRC sleepers."

Sub: Track Circuiting on 'D', 'E.Spl', 'E' & MG Routes.

- 1.0 As per the recommendations of Railway Safety Review Committee, following works of track circuiting have so far been approved on BG route as part of S&T Plan Head works or SRSF works:-
  - (a) A, B, C & D.Spl. Routes. Track Circuiting on the entire main line, including straight portion and turnout portion.
  - (b) D Route. Track circuiting from FM to FM, FM to BSL Straight portion and Home to FM Straight portion.
  - (c) E.Spl & E Routes. FM to FM only.
- 2.0 No work of Track Circuiting on MG route have been approved so far, excepting those stations, which are included in sanctioned Gauge Conversion (GC) works.
- 3.0 Provision of Track Circuiting on remaining BG & MG sections has been examined in detail and the following has been decided:-

### A. BC Routes - 'D', 'E.Spl'. & 'E'

- (i) Track Circuiting work proposals for FM-BSL (Straight) & Turnouts, FM-Home (Straight) & turnout portion on 'D' & 'E' Spl route be submitted by Railways for sanction.
- (ii) Track Circuiting on E route be limited to only FM-FM and FM-BSL & FM-Home Straight portion. While FM to FM Track Circuiting on E route is already sanctioned, proposals for straight portion track circuiting on 'E' route be submitted for sanction.

#### B. MG Routes

(i) Stations where GC is sanctioned & likely to be commissioned by 31.3.2006 - At such stations, Track Circuiting should be done along with Gauge Conversion, as sanctioned.

- (ii) Stations where GC is not sanctioned: FM to FM Track Circuiting at such stations can be provided either by replacing the existing sleepers with MG PRC sleepers or by using Axle Counters. However, stations, where track renewals or casual renewals are already sanctioned, track circuits should be provided using MG PRC sleepers.
- (iii) Stations where GC is sanctioned but is not likely to be commissioned in near future, i.e., by 31.3.2006 For such sections, FM to FM Track Circuiting should be done by providing BG PRC sleepers with MG seats right at the stage, chargeable to GC sanctioned work.
- C. Complete Track Circuit at Junction & other important stations on BG & MG Routes.

High priority should also be given for complete track circuiting at all those stations, where regular shunting is performed, junction stations and other important stations where trains stop for longer duration on all BG & MG routes as advised already vide ML's DO letter No.2003/Sig./W/5/1, dated 27.8.2003.
