Sub : Submission of Proposals for creation of SAG/HAG posts for S&T works-streamlining of procedure.

At present, proposals for creation of work charged post in SAG and above are being sent separately by CPO of the Railways based on individual proposal prepared by CSTE(Open Line) and CAO(Con.), which results in difficulties in keeping track of proposals from Railways for creation and/ or extension of currency separately for CSTE (Open Line) and for CAO (Con.). Further due to fractional entitlements, the required number of SAG posts for S&T works as warranted by the workload as per norms, is not sanctioned.

The matter has been considered in the Board's office and Board (ML, ME, FC and MS) have decided that:

- i) All proposals in respect of S&T Construction and project organization should be processed/dealt as a single proposal (combining S&T works being executed under all plan heads) by CSTE of the Railway (cadre controlling officer), through CPO with GM's approval, which would then be clubbed with the proposals of other Deptts. of Construction Organisation for submission to Board's office.
- ii) In partial modifications of the instructions issued vide (ii)(b) of Board's letter No. 92/SIG/G/1 dated 20-07-1994, on Zonal Railways, where only one CSTE/Con. post is justified based on the total outlay for S&T works under various plan head, the same will be kept under the control of CAO(Con.) for executing the S&T works under all plan heads including S&T replacement and safety enhancement works under plan head 33 and 29. On Railways, where two posts are justified, one CSTE(Con.) each shall be under the control of CAO (Con.) and CSTE (Open Line), and where more than two posts are justified, the additional post(s) of CSTE(Con.) shall be placed under CSTE(Open Line) or CAO (Con.) depending on the relative work load in terms of outlay under each.

This issues with the concurrence of Establishment & Finance Directorates.
