**Sub: Contract No. 2024/RS(I)/954/194/1927 dated 15.02.2024 for
manufacture and supply of Wagons.**

Ref: BCL/CMD/PED/RS(S)/2024-25/02 dated 02.07.2024.

- 1.0 Your request for extension of delivery period of the subject contract without LD and DC, under reference, has been examined in Board's office and it is intimated that the same is not agreed to. However, in consideration of your request, it has been decided to extend the delivery period of the subject contract for manufacture and supply of balance qty. of 279 nos. BVCM wagons beyond 14.08.2024 upto 31.10.2024 with LD & DC.
- 2.0 The above extension in delivery period will be subject to the following conditions:
 - (a) Liquidated Damages at the rate prescribed in clause 12.0 of Indian Railways General Tender conditions of Contract for manufacture and supply of wagons will be applicable for balance quantity of supplies made after 14.08.2024, if so decided in terms of the contract, from any outstanding dues against this contract or any other contracts for which the President of India is the purchaser notwithstanding the grant of this extension.
 - (b) that no increase in price on account of any statutory increase in or fresh imposition of GST, freight or on account of any other tax or duty leviable which takes place after 14.08.2024, shall be admissible on such of the said stores as are delivered after the said date;
 - (c) that notwithstanding any stipulation in the contract for increase in price on any other ground, no such increase which takes place on or after 14.08.2024, shall be admissible on such of the said stores as are delivered after the said date;
- 3.0 However, the purchaser shall be entitled to the benefit of any decrease in price on account of reduction in or remission of GST or on account of any other tax or duty or on any other ground as stipulated in the Price Variation clause which takes place after the expiry of the above mentioned date namely 14.08.2024.
- 4.0 All other terms and conditions of the subject contract will remain unchanged.
