Amendment No. I

Sub: Contract No. 2022/RS(I)/954/164/1897 dated 06.06.2022 for manufacture and supply of Wagons.

Ref: Your Letter No. D-010 dated 06.03.2023 & 21.03.2023.

- 1.0 Your request for re-fixation of delivery period of the subject contract, under reference, has been examined in Board's office and it is intimated that the same is not agreed to. However, in consideration of your request, it has been decided to extend the delivery period of the subject contract for manufacture and supply of 1st lot for balance quantity of 32 nos. wagons beyond 28.02.2023 upto 15.04.2023 with LD & DC.
- 2.0 The above extension in delivery period will be subject to the following conditions:
 - (a) Liquidated Damages at the rate prescribed in clause 12.0 of Indian Railways General Tender conditions of Contract for manufacture and supply of wagons will be applicable for 1st lot of balance quantity of 32 nos. supplies made after 28.02.2023, if so decided in terms of the contract, from any outstanding dues against this contract or any other contracts for which the President of India is the purchaser notwithstanding the grant of this extension.
 - (b) that no increase in price on account of any statutory increase in or fresh imposition of GST, freight or on account of any other tax or duty leviable which takes place after 28.02.2023, shall be admissible on such of the said stores (32 nos. against 1st lot) as are delivered after the said date;
 - (c) that notwithstanding any stipulation in the contract for increase in price on any other ground, no such increase which takes place on or after 28.02.2023, shall be admissible on such of the said stores (32 nos. against 1st lot) as are delivered after the said date;
- 3.0 However, the purchaser shall be entitled to the benefit of any decrease in price on account of reduction in or remission of GST or on account of any other tax or duty or on any other ground as stipulated in the Price Variation clause which takes place after the expiry of the above mentioned date namely 28.02.2023.


