BASE MONTH: Feb., 2022.**

1. The increase/ decrease in the price of wagons (for SS wagons) quoted for would be governed by the following escalation formula:-

C<sub>0</sub> = WPI for "Castings" applicable for the Base month 2 months prior to tender opening month.

TP<sub>0</sub> = The "Transfer Price of one wheel set of RWF" applicable for the Base month 2 months prior to tender opening month.
