

- Your request for re-fixation of delivery period of the subject contract, under reference has been examined in Board's office and it is intimated that the same is not agreed to.  - that notwithstanding any stipulation in the contract for increase in price on any other ground, no such increase which takes place on or after 17.08.2022, shall be admissible on such of the said stores as are delivered after the said date;





- However, the purchaser shall be entitled to the benefit of any decrease in price on account of reduction in or remission of GST or on account of any other tax or duty which takes place after the expiry of the above mentioned date namely 17.08.2022
- 4.0 All other terms and conditions of the subject contract will remain unchanged.
