Sub: Contract No. 2021/RS(I)/954/154/1887 dated 08.03.2022 for manufacture and supply of Wagons.


You have requested for differential advance payment against the subject contract as per Railway Board's letter referred 2 above. However, it is noted that you are getting wheel sets against Indemnity Bond as per Railway Board's letter referred 3 above. Therefore, it has been decided in Board's office to amend the Clauses of the subject contract regarding advance payment as under :

Clause 10.2 (Advance Payment):

Paying Authority shall pay interest free advance (including differential advance of Rs. 14,00,36,500/-) amounting to 10% of the contract value (excluding price of wheel sets prevailing for the quarter Jan-Mar, 2022 and inclusive of current GST@ 18%) i.e. Rs. 68,57,61,720/- (Rs. Sixty Eight Crore Fifty Seven Lakh Sixty One Thousand Seven Hundred Twenty only) against the subject contract. This advance payment will be interest free and payment will be released after suitable Indemnity Bond have been submitted by you to the full satisfaction of Paying Authority, and the additional conditions mentioned in subsequent clauses.

Clause 10.3 (For recovery):

For recovery of the above mentioned interest free advance (including differential advance of Rs. 14,00,36,500), proportionate deductions for an amount of Rs. 68,57,61,720/- (Rs. Sixty Eight Crore Fifty Seven Lakh Sixty One Thousand Seven Hundred Twenty only) shall be made by the Paying Authority from the bills submitted by the firm against the subject contract. This advance should be utilized by M/s. BCL only for the subject contract.

Clause 10.4: Advance payment of Rs 68,57,61,720/- (including differential advance payment of Rs 14,00,36,500) will be released subject to fulfillment of the following conditions:-

- (a) The wagon builder will submit documentary evidence regarding utilization of advance to the concerned PFA within 45 days of release of advance failing which recovery of advance may be initiated.
- (b) Any outstanding advance is to be recovered fully within original delivery period. No advance will be allowed during extended delivery period.
- (c) Cost of Wheel sets supplied against Indemnity Bond to the firm against the subject contract as per Board's letter referred 3 above, is to be deducted proportionately from bills payable to the firm for supply of wagons to Indian Railways.
- (d) Firm is required to give declaration of passing on additional ITC benefit as per Clause 3.0 of the subject contract along with bills.
