 - that notwithstanding any stipulation in the contract for increase in price on any other ground, no such increase which takes place on or after 31.03.2023, shall be admissible on such of the said stores as are delivered after the said date;
- 3.0 However, the purchaser shall be entitled to the benefit of any decrease in price on account of reduction in or remission of GST or on account of any other tax or duty or on any other ground as stipulated in the Price Variation clause which takes place after the expiry of the above mentioned date namely 31.03.2023.

- 4.0 All other terms and conditions of the subject contract and subsequent amendments will remain unchanged.
- 5.0 Please acknowledge receipt of this amendment.
