Grease Seals against the subject material shall be admissible on such of the said stores as are delivered after the said date;
- 3. However, the purchaser shall be entitled to the benefit of any decrease in price on account of any other tax or duty which takes place after the expiry of the above mentioned date namely 21.04.2022 for 2<sup>nd</sup> lot of quantity of 99,326 nos. against the subject material.
- 4. All other terms and conditions of the subject contract remain unchanged.
