- ii) One copy to the Paying Authority.
- iii) One copy to the supplier as acknowledgement.
- c) Where 20% payment is to be made after the successful installation and proving test of the machine, the consignee should in addition issue Proving Test Certificate on the Proforma as per Annexure-M of specification ass evidence of successful commissioning of machine and carrying out of the Proving Test to his entire satisfaction. The Proving Test Certificate in original to be furnished to:
  - i) The Supplier
  - ii) Paying Authority
- d) Consignee will also get the site ready well in time for installation and commissioning of machine as per the specification.
- e) Authority to sign the Certificate: To be signed by a Gazetted Officer not below the rank of J.A. Grade. May be signed by a Senior Scale Officer if he is the Shop Incharge. The Officer must sign under his own seal and not on behalf of any senior officer. The consignee should advise the supplier within 45 days the damage/shortage, which has occurred in transit.
