**Amendment No. III**

1.0 In consideration of your above referred request, it has been decided by the Competent Authority to cancel the balance quantities of 1<sup>st</sup> & 2<sup>nd</sup> lot and entire quantities of 3<sup>rd</sup> & 4<sup>th</sup> lot of wagons against the subject contract without any financial repercussions on either side under Force Majeure Condition.

2.0 Accordingly, Clause 2.0 of the subject contract is amended as below:-


