Sub.: Inclusion of IGBT based 3-phase drive propulsion equipment for 3-phase electric locomotive in to the list of items (appearing on UVAM) and restricted to be procured from approved sources.

Railway Board has decided that the item "3-Phase drive propulsion equipment for 3-phase Electric Locomotive" shall be procured from vendors listed on UVAM, with following conditions:

- (i) The procurement shall be restricted to vendors listed on UVAM, as per relevant Railway Board instructions, for tenders issued after one calendar year from the date of issue of this instruction.
- (ii) CLW and BLW shall be the vendor approving agencies for this item.
- 2. CRIS to provide suitable provisions on recording of failures, both on account of quality and supply, of vendors listed on UVAM by Railway Units.
- 3. System of periodic sharing of failure data and review of the same should be continued and Purchase Officers of respective PUs should be included in the deliberations, so that they are aware of developments that may influence changes in the status of vendors listed on UVAM.
- 4. CLW and BLW shall give adequate publicity, well in time, to all the stakeholders, including vendors, permitting the vendors an opportunity to meet the requirement of

listing on UVAM. CLW and BLW shall be competent to decide on the detailed procedure for stakeholder communication and publicity.
