
Sub.: Inclusion of Bill of Materials (BoM) in the Online Vendor Directory (UVAM).

Ref.: Railway Board letter No. 2023/RS(G)/779/6 dated 19/03/2025 (copy enclosed)

Railway Board, after receiving references from various Railway Units, had decided, vide letter dated 19/03/2025 under ref., to include, on UVAM, the Bill of Materials (BoM) of all items listed on UVAM.

2. Railway Board desires that the first time uploading of BoM should be completed by 30/06/2025. Further, subsequent updation should also be ensured in a timely manner, i.e. not beyond 7 days from the date of acceptance of new BoM or any modification to existing BoM. In this regard it has also been decided that the concerned PED/ ED/ HoD responsible for vendor approval, for items listed on UVAM shall be responsible for ensuring timely uploading and updation of BoM on the UVAM.
3. DG/ RDSO and GMs of the nominated vendor approval units shall indicate the progress made in this regard in the Monthly Confidential Demi-Official (MCDO) letter submitted to Railway Board.
4. CRIS to ensure necessary provisions on UVAM latest by 10/06/2025.
5. This issues with the approval of Railway Board (MTRS).



Sub.: Inclusion of Bill of Materials (BoM) in the Online Vendor Directory (UVAM VD) for loco items.

References have been received in Railway Board, regarding inclusion of Bill of Materials (BoM) on the Online Vendor Directory (UVAM VD).

2. The matter has been reviewed in Railway Board and it has been decided that:
- (i) BoM of all Items listed on UVAM, with Vendor specific versions, including archived BoMs, should be available on UVAM so as to ensure that the Railway Units are aware of the product being procured, tendered, accepted and during use.
 - (ii) BoM available on UVAM, and the archives of the same including vendor specific BoM, should be downloadable by authorized officials.
 - (iii) Any change in BoM whether technically significant or technically insignificant with or without financial repercussions should be recorded in the archives of UVAM. CRIS is requested to devise such a mechanism on UVAM portal.
 - (iv) The BoM may be allowed to be accessible and downloadable only by designated railway officials, i.e. concerned PHODs, TC members and concerned HODs of technical departments. PCMM of Railway Units may be empowered by CRIS to authorize a railway official to access and download the BoM from UVAM.
 - (v) Only vendor approving agencies shall be authorized to upload revised BoM. Any change in BoM shall be along with declaration on classification of change as to whether it is technically significant or necessary and whether with financial repercussions or without financial repercussions.
 - (vi) No change in BoM shall be permitted in a bid after tender opening date.
 - (vii) No change in BoM having financial repercussions or significant technically shall be permitted in a contract. Information about applicable BoM should be indicated in the Purchase Order/ Contract.
