## Amendment No. I

Sub: Developmental Contract No. 2023/RS(I)/174/177/1910 dated 08.05.2023 for manufacture and supply of Constant Contact Side Bearers (CCSB) for BOXN type wagons.

- 1.0 In consideration of your request under reference, it has been decided to re-fix the delivery period of the subject contract for 60 days from the date of issue of amendment without Liquidated Damages but with Denial Clauses.
- 2.0 The above extension in delivery period will be subject to the following condition:
- (a) that no increase in price on account of any statutory increase in or fresh imposition of any other tax or duty leviable which takes place after 07.05.2024 for balance quantity of CCSBs against the subject contract shall be admissible on such of the said stores as are delivered after the said date;
- 3.0 However, the purchaser shall be entitled to the benefit of any decrease in price on account of any other tax or duty which takes place after the expiry of the above mentioned date namely 07.05.2024 for balance quantity of CCSBs against the subject contract.
- 4.0 All other terms and conditions of the subject contract will remain unchanged.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
