**Sub: Cancellation of balance quantity of 390 Nos. BCNA wagons against Contract No. 2020/RS(I)/954/130/1863 dated 30.09.2020 for manufacture and supply of Wagons.**

**Ref: Board's letter No. 2020/RS(I)/954/130/1863 DTD 02.01.2023.**

1.0 You have failed to supply balance quantity of 390 BCNA wagons against the subject contract placed on M/s. Titagarh Wagons Ltd. (formerly M/s. Cimmco Ltd.) despite delivery period extensions and since you have not requested for further DP extension with LD & DC in response to letter under reference, it has now been decided to short close the subject contract on your default, by cancelling the balance quantity of 390 nos. BCNA wagons and forfeit the Bank Guarantee submitted by you towards Security Deposit for an amount of Rs. 5,00,00,000/- (Rs. Five Crore only), as per contractual obligations in terms of IRS conditions of contract.

2.0 Accordingly, the quantity of the subject contract is amended as indicated below:
