- 1.0 Your request for re-fixation of delivery period of the subject contract, under reference, has been examined in Board's office and it is intimated that the same is not agreed to. - 3.0 However, the purchaser shall be entitled to the benefit of any decrease in price on account of any other tax or duty which takes place after the expiry of the above mentioned date namely 29.03.2023 for balance (original) quantity of CCSBs against the subject contract.
- 4.0 All other terms and conditions of the subject contract will remain unchanged.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
