## Amendment No. IV

- 1.0 Your request for re-fixation of delivery period of the subject contract, under reference, has been examined in Board's office and it is intimated that the same is not agreed to. - 4.0 All other terms and conditions of the subject contract will remain unchanged.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
