1.0 In exercise of the rights reserved under Clause 12.0 (Quantity Option Clause) & Clause 13.0 (Changing type-wise wagon mix in the order) of the Subject Contract, Ministry of Railways (Railway Board) on behalf of the President of India have decided to partially increase the ordered quantity of BOBRNHSM2 from 1,017 Nos. to 1,536 Nos. BOBRNHSM2 wagons (by 519 Nos. BOBRNHSM2 Wagons) on the same price and terms and conditions of the subject contract.
