- 3. The Rail Freight rate for sanpada destination will be continuing applicable for the remaining period of FY 2023-24 and at starting of FY from next year onwards, an annual freight will be circulated from Railway Board subject to revision, if any, made during the year.
- 4. As per terms and conditions of contract, actual Railway freight would be reimbursed if the material is dispatched by Rail. In case the material is dispatched by road, the freight charges would be road freight or calculated railway freight whichever is the lower.
