- 1. Railway Board, vide letters referred above, had issued instructions on implementation of Public Procurement (Preference to Make in India) Order, 2017 (PPP-MII Order). All Railway units have confirmed incorporation of the same in their procurement process.
- 2. Railway Board has been receiving references alleging non-compliance of PPP-MII Order, especially; Para 10(d) of the order. Railway Board had, vide letter referred at (iii) above, specifically requested Railway Units to examine any cases of alleged violation of Para 10(d) of the Order and had sought detailed report, by 31/01/2020 and subsequently on regular basis. No case has been reported till date by any of the Railway Units.
- 3. While reviewing implementation of PPP-MII Order on Indian Railways it has been decided that Para 10(d) of the PPP-MII Order, shall be part of all tender documents of Indian Railways as a specific tender condition, for procurements on which PPP-MII Order is binding. Accordingly the condition may be incorporated in the tenders.

Compliance of the order may be intimated to Board.
