Sub: Quality procurement of material - Inspection Policy

- 1. With a view to improve the quality level of material being used in Indian Railways, it has been decided that use of 'ISI' mark product will be actively encouraged.
- 2. Thus for all items which are to be purchased to IS specification, the Purchase Officer will ascertain whether for the given item, these are ISI certified manufacturers or not. If there exists ISI certified manufacturers, then the following will be incorporated in the tender schedule:

"Purchase of the item will be made for ISI marked product only."

- 2.1 Accordingly, for such items, the purchase will be restricted to ISI marked product only.
- 3. If the order is placed directly on an ISI certified manufacturer, the material can be accepted on firm's WTC.
- 3.1 In such cases there will no need for any 3rd party inspection for ISI marked product from ISI certified manufacturer and inspection clause will indicate "acceptance on Firm's WTC".
