(iii) Railway Board's letter No 2020/RS(G)/779/2/Pt 1 dated 25.09.2020.

Vide letter under reference (i) Railway Board had requested Railway Units to examine any cases of alleged violation of Para 10(d) of the Order and had sought detailed report, by 31-01-2020 and subsequently on regular basis. No case has been reported till date by any of the Railway Units.

2. Further, vide letter under reference (ii) Railway Board had instructed that Para 10(d) of the PPP-MII Order, shall be part of all tender documents of Indian Railways as a specific tender condition, for procurements on which PPP-MII Order is binding.

3. Since then, the policy has been revised and a revised 'Make in India' policy has been issued by Department of Promotion of Industry and Internal Trade which was circulated by Railway Board to all field units vide Railway Board letter dated 25-09-2020 (under ref. iii)

4. The Revised 'Make in India' policy, inter alia, revised Clause 10(d) also. You are advised to incorporate provisions of revised Clause 10(d) of the policy in place of the existing clause in your tenders for clause 10(d) of the old policy, if not already done. Draft clause is enclosed for guidance. Compliance of the same may be sent to Board by 10-06-2021.

5. Further, please inform Board if any complaint/representation is received by your railway unit with regard to Clause 10(d) of the policy. The details may please be provided to Board by 15.06.2021.

**RECIPROCITY CLAUSE TO BE INCLUDED AS A SPECIAL TENDER CONDITION
IN EACH TENDER AS PER 'MAKE IN INDIA' POLICY**

CLAUSE

Bidders may please note that –

Entities of countries which have been identified by the Nodal Ministry/Department as not allowing Indian companies to participate in their Government procurement for any item related to that Ministry/Department shall not be allowed to participate in Government procurement in India for all items related to that nodal Ministry/Department, except for the list of items published by the Ministry/Department permitting their participation.

The term entity of a country shall have the same meaning as in the FDI policy of DPIIT as amended from time to time.
