Invitation of Developmental tenders through open tender mode as per requirement as per Railway Board letter No 99/RS(G)/709/1/Pt dated 13-01-2015 (latest amended) per item-


	Tender issuing authority level	Value limit (Without Finance Concurrence)
(i)	PCMM	Full powers
(ii)	CMM	Upto Rs 25 Lakhs

Note -

- Finance concurrence for special condition as per para-B(iii) of the Railway Board letter No 99/RS(G)/709/1/Pt dated 13-01-2015 shall not be required for developmental tenders for quantities upto 10 % of annual requirements for A category items and upto 20 % of annual

- requirements for B and C category items, subject to maximum of Rs 5 Cr. For quantities beyond these limits, Finance concurrence shall be required as per para B (iii) of the letter.
- ii. Quantities for tender should be bare minimum as per letter no 99/RS(G)/709/1/Pt dated 13-01-2015. Consultation with concerned user department should be done.
 - iii. These powers shall be exercised by HQ officers only.
