

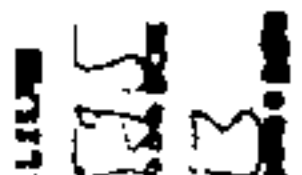

Read: For all stores procured against DGS&D Rate Contract/ ad-hoc contract, the Inspection officer would be:


- (i) User Departments/DDO/Consignee itself or any authority/ agency appointed by them or
