

Vide above referred letter dt. 5.7.2012 Public Procurement Policy of GOI in respect of procurement of goods and services, produced and provided by MSME, by its ministries, departments and PSUs was circulated for guidance and compliance.

COS/NCR, vide his letter dated. 10.10.2012, sought clarification/direction from Board on some points related to the policy. Areas pointed out by NCR and clarification thereon are placed below in juxtaposition:
