Sub: Ordering on approved sources in Part-II

Ref: Board's letter of even no. dated 06-12-2007

In the COS Conference of Controller of Stores, held in Chennai on 18th and 19th of December, 2008, one of the Railway has sought for certain clarification on above mentioned letter, as reproduced below:-

- (1) Applicability of Para (2) of the Board's letter of even no. dated 06-12-2007 to Part-II approved sources whose rates are higher than that of lowest Part-II tenderers.
- (2) Whether the performance of other Railway Units/ PUs may be considered for other than lowest part-II source or it is restricted to performance of that Railway only.

The matter has been examined in Board's office and accordingly it is clarified that the spirit of Para 2(c) of Board's letter of even no. dated 06-12-2007 signifies that Para(2) of this letter will apply to all Part-II approved tenderers falling within the zone of consideration.





Keeping above spirit in view on the matter, Para (3) of Board's letter of even no. dated 05-05-2006 may be modified as under:-

"It is also likely that there may be cases where more than one Part-II sources are within the zone of consideration on the basis of competitive price ranking with satisfactory past performance on any Railway/Production Unit. In such cases, each Part-II source can be considered for ordering in the same manner as indicated in Para 2."




