Sub : Delegation of powers for acceptance of recommendation of survey committee to reclassify stores in stock.

Ref : Board's letters of even number dated 04-06-2004 and 04-02-2005.

1.0 The issue of suitable revision in the powers delegated to COS and his officers to reclassify stores as second hand or scrap on the recommendation of survey committee has been raised by Zonal Railways in the various conferences of COSs and CMMs.

2.0 This issue has been examined in the Board's Office in consultation with associate finance and it has been decided to partially modify stores code para 2223 of Indian Railways Stores Code Vol.II by enhancing:

- (i) The powers of COSs to reclassify the stores in stock and to rate them second hand or scrap from the prevailing Rs. One Lakh per item to Rs.5 lakh per item based on book value of item before reclassification.
- (ii) The re-delegation power of COS, to reclassify the stores in stock and to rate them second hand or scrap to CMMs, Dy. CMMs and depot officers (in Sr. Scale) upto Rs.3 lakhs, Rs.1 lakh and Rs.25,000/- per item respectively.
- (iii) The power of depot officers to reclassify the stores in stock and to rate them second hand or scrap from Rs.2000 per item to Rs.5,000/- per item without processing the same through survey committee.

Necessary correction slip in this regard for stores code will be issued in due course of time.
