Sub: Refurbishing of old ICF Coaches to work as Mobile-Stores—cum-work shop-cum-Rest Van for track machines and equipping of CPOH

workshops as per IRTMM 2019.

Ref: Bd's letter of even No. dated 26.06.2023.

(i) Zonal Railways are requested to recall the above referred letter in which it has been brought out that camping coaches are to be provided with each track machine to function as a workshop & mobile resting facility for the track machine staff for day-to-day attention of the machines. It is reiterated that the **pace of refurbishment** of old ICF coaches into camping coaches' needs to be expedited as without proper accommodation at remote locations Track Machines staff face hardship adversely affecting the working of Track Machines.

(ii) **CPOH workshop** play very important role for carrying out POH of the large on Track Machines; so all the facilities as per IRTMM 2019 are required in these workshops for proper POH. Besides CPOH workshop, proper facilities of maintenance of track machines in form of full fledged Zonal Track Machine Maintenance Depots (**STMMD**) & Satellite Track Machine Maintenance Depots (**STMMD**) is essentially required to carry out IOH & other scheduled maintenance. STMMD which are not yet constructed & commissioned shall be given high priority for construction & commissioning with full facilities as per IRTMM. Adequate facilities at ZTMMD should also be reviewed according to the proposed number of Machines to be handled **as per Mission 3000MT** (including the outsourced track machines).

Zonal Railways are advised to take action early on the above infrastructure work and apprise the position regularly through PCDO and monthly booklet to Railway Board.
