**Sub: Modification / Technical Upgradation of existing M/s Plasser make HOT-3X, HOT-CSM & BCM machines under Mid-life Rehabilitation (MLR) to improve performance of the existing old machines.**

Due to increased utilization of existing tracks by ever increasing traffic, maintenance block spells available for track maintenance have decreased, leading to the requirement of integrated track machines like HOTS-3X tamping machine having features of two machines (tamper + track stabilizer). IR is having 18 nos. HOT-3X and 70 nos. HOT-CSM machines which are not equipped with integrated track stabilization system, hence require separate DTS machines for stabilization of track.

The PCEs of Zonal Railways are advised to carry out the cost benefit analysis of the proposed MLR/Technical upgradation of the 62 Track machines ( 17 nos. HOT-3X, 30 nos HOT-CSM and 15 nos. BCM machines) (**list attached**) type-wise & age-wise and arrange to furnish the outcome of the analysis and recommendation accordingly to this office so that the proposal for Mid life rehabilitation and technical upgradation work of HOT3-X to HOTS-3X, HOT-CSM to HOTS-CSM and making BCM machines fit for deep screening of platform lines, may be processed in Board's office.

In this regard the Zonal Railways may seek the experience of Northern Railway which is taking up Upgradation work of HOT-3X-3964 to HOTS-3X and South Central Railway which has taken up the upgradation work of one BCM-339 machine as per the budgetary offers submitted by OEM M/s Plasser (Copies enclosed).

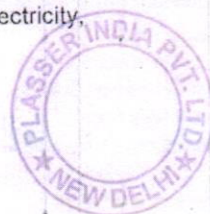
