Vide above referred letter dated 31.10.13, price of 60 kg/52 kg 90 UTS prime rails (IRS-T-12 Gr. 880) for supply to Zonal Railway by Steel Authority of India Limited for the period 01.01.2008 to 31.03.2012 was circulated and it was mentioned in NB-7 that existing provisional price as circulated vide this office letter of even no. dated 26.12.2008 is to be followed till the time new prices are finalized for the period 31.03.12 onwards.

Issue of costing of rails for the period 01.04.12 to 31.12.13 has been referred to CA/Cost/Ministry of Finance. Pending finalization of cost of rails by CA/Cost, Ministry of Finance, provisional ex-works base price of 60 kg/52 kg 90 UTS prime rails (IRS-T-12 Gr. 880) for supply to Zonal Railway by Steel Authority of India Limited has been approved by Board as Rs.51,655/MT and it is to be paid from 01.02.14.
