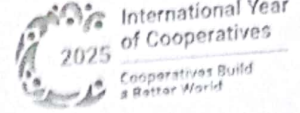

2. Corrigendum issued vide Board's letter of even no. dated 01.04.2025.

Vide above-referred letters dated 26.03.2025, followed by corrigendum dated 01.04.2025, the provisional price of 60kg/52kg 90 UTS Prime Rails (IRS: T-12/2009 Grades 880, R260) for supply to Zonal Railways by Steel Authority of India Limited (SAIL) was circulated against pending finalization of rail cost by CA/Cost. Now, the prices of 90 UTS Prime Rails 60kg and 52kg (Grades R260, 880, and Head Hardened Rails 350HT) for the period from 01.04.2023 to 31.03.2024 have been approved by the Competent Authority. The approved prices are as under:

Period	Price of 90 UTS Prime rails, 60kg and 52kg (Gr R260, 880) (Ex. works) per MT excluding Taxes.
01.04.2023 TO 31.03.2024	Rs. 79,484/- per MT (Rupees Seventy Nine Thousand and Four Hundred Eighty Four only).

Period	Price of Head Hardened Rails 60kg (R350HT) (Ex. Works) per MT excluding Taxes.
01.04.2023 TO 31.03.2024	Rs. 105,352/- per MT (Rupees One Lakh Five Thousand and Three Hundred Fifty Two only).

NB:

1. Rail price for the period 01.04.2023 TO 31.03.2024 indicated above is for all lengths of rails i.e. 13m/26m/260m etc inclusive of all components and are complete. Nothing is payable extra on any account. However, GST is payable extra as per actual.
2. The Competent Authority has approved provisional price of 60kg and 52kg (Gr R260, 880) rails as Rs. 74000/- Per MT (Rupees Seventy-Four Thousand only) and of Head Hardened Rails 60kg (R350HT) as 97500/- (Rupees Ninety Seven Thousand and Five Hundred only) per MT (Ex. Works), excluding Taxes, to be applicable for supplies made from 01.04.2025 onwards, till such time pending recommendation of final price or new price is approved.
3. These rail prices are ex-works and railway freight in supply of rails would be payable by Zonal Railways.

4. The inspection charges upto 29.11.2023 shall be paid directly by the Railways to the Inspection Agency and from 30.11.2023 onwards, all terms and conditions related to the payment of inspection charges will apply as per the new Contract Agreement No. TKP-1-2023 for Selection of Inspecting Agency for "Testing & Inspection of Rails as per IRS-T-12-2009. Specifications with latest amendments" commenced on 30.11.2023.

Under this arrangement, as conveyed in the Board's letter dated 21.11.2023, SECR has already been nominated as the Nodal Railway for making payments of inspection charges related to the above contract to all Zonal Railways/PSUs.

5. In case of rejection, recovery shall be due and made as per Railway Codal Provision.
