Police Personnel and personnel of certain para-military organisations are entitled to the facility of purchasing tickets in exchange of Police Warrants which are addressed to a particular station master who issues tickets (.) MINISTRY OF RAILWAYS HAVE DECIDED THAT THE EXISTING SYSTEM MAY BE REVISED AS UNDER (.) (i) POLICE WARRANT SHOULD BE ADDRESSED TO "INDIAN RAILWAYS" AND NOT TO STATION MASTER ; (ii) POLICE WARRANTS MAY BE EXCHANGED FOR TICKET FROM ANY PRS TERMINAL IRRESPECTIVE OF THE STATION FROM WHICH THE JOURNEY IS TO ORIGINATE AND (iii) THE WARRANTS COLLECTED AT THE STATION SHALL BE BILLED BY THE TICKET ISSUING RAILWAY TO THE HEADQUARTERS OF THE CONCERNED POLICE/PARA MILITARY ORGANISATION (.) The Central/State Governments and concerned Para Military organisations are being advised in this regard (.) However, IF SOME ORGANISATION HAS ADDRESSED THE WARRANT TO SOME STATION MASTER, THE SAME SHALL BE HONoured AT ALL PRSs AS MENTIONED IN THE ABOVE REVISED PROCEDURE (.) This issues with the concurrence of the Accounts and Finance Directorates of this Ministry (.) Necessary instructions may be issued to all concerned immediately (.) Matter most urgent (.) 
