Sub: Provision of 5% discount on the total value of basic fare on booking of reserved ticket through UPI (Unified Payment Interface) including BHIM application across computerized Passenger Reservation System (PRS) counters.

In continuation of the above instructions, Ministry of Railways has decided to extend the currency of instructions regarding provision of 5% discount on the total value of basic fare on booking of reserved ticket through UPI (Unified Payment Interface) including BHIM application across computerized Passenger Reservation System (PRS) counters, up to 12.06.2022.


