
REF: Commercial circular No. 24 of 2009 dated 16.07.2009 and other instructions issued from time to time in this regard.

The need for review of the scheme of Izzat Monthly Season Ticket was highlighted in the Consultative Committee Meeting. Further, in order to prevent the misuse of the scheme and also to ensure that the scheme actually reaches the person belonging to low income category, it has been decided as under:

- (i) Income certificates issued by the authority for issue of IZZAT MST, should also be verified by local Government Officials such as BDO, Tehsildar etc.
- (ii) A copy of the proof of residence such as Voter Identity Card, Driving License, Electricity Bill etc should also be retained for issue of the IZZAT Monthly season tickets and the original should also be inspected.
- (iii) There shall be no change in other conditions of the Izzat Monthly Season Ticket.

This issues with the concurrence of Finance Directorate of Ministry of Railways.

The above changes will be effective from 15.10.2013.
