
Haulage Charges for 'Postal traffic' carried in Postal Vans and in Non-Postal Vans, for the year 2021-22 and 2022-23, were revised and issued vide Freight Marketing Circular No. 10 of 2022 dated 09.06.2022.

Ministry of Railways have decided to revise the Haulage Charges for 'Postal traffic' carried in Postal Vans and in Non-Postal Vans for the year 2023-24 as under:

Distance Slabs	Haulage Charges for the Postal traffic (2023-24) (in ₹ per berth per km)
0-500 km	₹1.15
501-1,000 km	₹0.73, subject to minimum realization of Haulage Charges applicable on distance of 500 km. (subject to minimum of ₹575/-)
1,001 km and above	₹0.61, subject to minimum realization of Haulage Charges applicable on distance of 1,000 km. (subject to minimum of ₹730/-)


2. Point to point charges shall be rounded off to the next multiple of five.

5. Necessary instructions may be issued to all concerned immediately.






