(iii) M/s Vedanta Aluminium Ltd. for transportation of Caustic soda



1.0 In terms of Rates Circulars under reference, sanction was accorded to grant rebate in freight for bulk Cement, Alumina and Caustic Soda when loaded and transported in privately owned BCCW, BTAPHP and BTCS wagons respectively subject to fulfillment of certain terms and conditions as stipulated therein. These instructions are valid up to 30.09.2011.

2.0 The matter has been reviewed and it has been decided to grant existing rebate conveyed vide Board's Rates circular under reference beyond 30.09.2011 for a further period of one year i.e. from 01.10.2011 to 30.09.2012 or till further review, whichever is earlier.

3.0 All other terms and conditions as stipulated in Rates Circular No.60 of 2009 and corrigendum thereto, Rates Circular No.15 of 2010 and Rates Circular No.26 of 2010 will continue to apply unchanged.

4.0 This issues with the concurrence of Finance Directorate of the Ministry of Railways.


