"The eligibility criteria regarding Minimum Annual Turnover as stipulated vide item no 1(a) and 1(b) of Annexure - I of FM Circular no 15 of 2022 stands deleted and provisions in this regard issued vide Para 1.1 of FM Circular no 11 of 2022 shall apply for Catering Units also."
