1.0 In terms of Board's letter of even number dated 31.03.2023 (Rates Circular under reference), guidelines were issued for Liberalized Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD) with effect from 01.04.2023 and is valid till 31.03.2024. Further in terms of Corrigendum no.1 and Corrigendum no.2 to above referred Rates Circular certain additional streams have been included under this scheme.

2.0 The matter has been reviewed. Sanction of the Competent Authority is hereby accorded for addition of following stream under TEFD policy:
