In terms of reference at (i) & (ii) above, Board's approval was communicated for 1. restarting of 25 Tonne axle load operation with such rolling stock as are fit/ certified for 25 Tonne axle load on various notified routes.

The routes are notified in terms of Annexure-IV of reference (iii) above. 2.

- Matter has been examined, in the light of South Eastern Railway's proposal, the Competent Authority has approved to add following routes, subject to the operation of 25T axle load at 45 kmph, in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above, as 25 Tonne axle load notified routes:

  - Rukni(RUI) Bhojudih Jn.(BJE) iv.
  - v. Bandhdih(BDIH) - Talgoria(TLE)
  - Bhojudih Jn.(BJE) Talgoria(TLE)-Mohuda Jn.(MHQ)
- Accordingly Annexure-IV of Rates Master Circular under reference (iii) above 4. shall be modified.
- The speed limit mentioned above can be reviewed by the Zonal Railway and may. 5. be revised as and when required.
- These instructions shall come into effect from 14.11.2024 and shall remain valid 6. till further advice.
