Sub: Rebate for traffic booked in NMG group of stocks, BCCNR, BCACM stocks in Traditional Empty Flow Directions.

Ref: Rates Circular No.07 of 2023 and corrigenda thereto.

- 1. Vide Rates Circular under reference, policy guidelines were issued for grant of rebate for goods traffic transported in Open, Covered and Flat stocks & Mixed Steel Rake Stocks in Traditional Empty Flow Directions.
- 2. The matter has been reviewed. In addition to the guidelines issued vide Rates Circular No.7 of 2023 and corrigenda thereto, the Competent Authority has decided to issue guidelines for grant rebate in haulage charges/ freight for traffic booked in automobile loading stocks when loaded in traditional empty flow directions with a view to generate additional traffic, revenue and to achieve improved utilization of automobile rolling stock by converting empty running of these stocks into loaded one. Details of the policy are as under:

i. Rebate:

- a) 20% for automobile traffic when booked in permitted stocks at applicable freight rates as mentioned in Rates Circular No. 32 of 2021 as modified from time to time.
- b) 20% for those permitted commodities, which are transported in the permitted stocks and charged at applicable class rate of Goods Tariff.

ii. Floor rate:

- a) There will be no floor rate for automobile traffic booked in permitted stocks.
- b) For those commodities, which are transported in permitted stocks and charged at applicable class rate, the NTR after 20% rebate should not be less than NTR at Class 100. However, the commodities chargeable at Class 100 and below, will continue to be charged at their respective class without any rebate.
- iii. Permitted commodities: Automobiles/ Motor Vehicles; Spare parts or other machinery; Lubricating Oil like Grease etc. (as per Rates Circular No. 32 of 2021 as modified from time to time).
- iv. Permitted Terminals: All terminals handling NMG group of stocks, BCCNR, BCACM stocks.
- v. Lead restriction: Short lead traffic of ≤ 100 kms shall not be eligible under this scheme.
- vi. Permitted stocks: NMG group of stocks, BCCNR, BCACM stocks.
- vii. Traditional Empty Flow Directions: The details of Inter-Zonal Traditional Empty Flow Directions for above stocks are attached as Annexure with this Circular.
- viii. The minimum offer of traffic shall be half rake of the permitted stock. This will be 12 wagons for NMG group, 14 wagons for BCCNR and 20 wagons for BCACM.
- ix. All other terms and conditions of TEFD policy shall apply.

- 3. PCOM, PCCM and PFA of the concerned Zonal Railway shall conduct a monthly review and audit of the scheme to assess the efficacy of the Scheme and may provide comments thereon to Board's Office for information.
- 4. Applicability: The instructions shall be operative w.e.f. 15.01.2024 till 31.03.2024.
- 5. Zonal Railways are advised to ensure that wide publicity is given to this Circular and also hold meetings with customers at Zonal and Divisional levels.
- 6. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate in the Ministry of Railways.
