- 1. In terms of above referred Rates Circulars, the Operation of Merry-Go-Round (MGR) System by Railways is valid up to 30.04.2024.
- 2. The matter has been reviewed and the Competent Authority has decided to extend the validity of the system beyond 30.04.2024 for a further period of one year i.e. up to 30.04.2025.
- 3. It has also been decided that for the operation of the MGR system beyond 30.04.2024, the current rates shall be enhanced by 5% (five percent).
- 4. The Zonal Railways where the system is operative should monitor the same with a view to increase traffic.
- 5. All other terms and conditions stipulated in above referred Rates Circulars shall remain unchanged.

6. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
