- 1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
- 2. In terms of reference (i) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
- 3. Eastern Railway has forwarded proposals with due approval of General Manager to include routes in the list of already identified CC+8 routes as below:
  - 1. Katwa Ahmedpur (Single Line) (KWAE AMP)
  - 2. Seoraphully Bandel (UP ML, DN ML, Rev Line) (SHE BDC)
  - 3.Bandel Saktigarh (UP and Rev Line) (BDC SKG)
  - 4. Barddhaman Katwa via Balgona (SL) (BWN KWAE via BGNA)
- 4. Sanction of the Competent Authority is hereby accorded to include the above referred routes of Eastern Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 60 kmph. This speed limit can be reviewed by the zonal railway and may be revised as and when required.
- 5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
- 6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 7. These instructions shall come into effect from 27.05.2024 and shall remain valid till further advice.
