- 2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
- 3. Northern Railway has forwarded proposal with due approval of General Manager to include routes in the list of already identified CC+8 routes as below:
 - (i) Delhi-Shahdara Jn.(DSA) Tapri Jn.(TPZ)
- 4. Matter has been examined and sanction of the Competent Authority is hereby accorded to include the above referred routes of Northern Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 60 kmph. This speed limit can be reviewed by the Zonal Railway and may be revised as and when required.
- 5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
- 6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 7. These instructions shall come into effect from 21.09.2024 and shall remain valid till further advice.
