- 2. In terms of reference (i) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
- 3. South East Central Railway has forwarded proposal with due approval of General Manager to include route in the list of already identified CC+8 routes as below:

Balaghat (BTC)-Katangi (KGE)-Tirodi (TRDI)

- 4. Sanction of the Competent Authority is hereby accorded to include the above referred route of South East Central Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 60 kmph for the 1042.885 to 1089.655 except Main line at km 1054/06-1054/13(380m Kaydi PH)) & 1060/10-1060/0(525m in WRI Yard) at speed restriction of 45 Kmph. This limit shall be reviewed by the Zonal Railway and may be revised as and when required.
- 5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
- 6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 7. These instructions shall come into effect from 07.09.2024 and shall remain valid till further advice.
