1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.

2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.

- 3. Southern Railway has forwarded proposal with due approval of General Manager to include routes in the list of already identified CC+8 routes as below:
 - 1. NAGORE(NCR)-KARAIKAL(KIK)(UP&DN)
 - 2. KARAIKAL(KIK)-PERALAM(PEM)(UP&DN)
- 4. Matter has been examined, and sanction of the Competent Authority is hereby accorded to include the above referred routes of Southern Railway in the list of already identified CC+8 routes subject to prescribed permissible speed. This speed limit can be reviewed by the Zonal Railway and may be revised as and when required.

5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.

6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.

7. These instructions shall come into effect from 25.07.2025 and shall remain valid till further advice.
