
Sub: Running of freight trains on CC+8 tonne routes.

- 1 Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
3. North Eastern Railway has forwarded proposal with due approval of General Manager to include the following routes in the list of already identified CC+8 routes:
 - i. Varanasi (BSB) (excl.) - Jhusi (JI) (incl.) (UP & DN Line)
 - ii. Jhusi (JI) (excl.) - Prayagraj Rambag (PRRB)(excl.) (Double new line)
 - iii. Prayagraj Rambag (PRRB) (incl.) - Prayagraj (PRYJ) (excl.)(UP & DN Line)
4. Matter has been examined and sanction of the Competent Authority is hereby accorded to include the above referred routes of North Eastern Railway in the list of already identified CC+8 routes subject to permissible speed as prescribed by Engineering Department which can be reviewed and may be revised as and when required by the Zonal Railway.
5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 28.06.2025 and shall remain valid till further advice.


