Sub: Charges for haulage of empty wagons on private account.
Ref: Board's letter of even number dated 15.12.2008 (Rates Circular No 76 of 2008)

In term of Rates Circular No.76 of 2008, the charges for haulage of empty wagon on private account was notified. The matter has been reviewed. Sanction of the Central Government is hereby accorded to revise the charges for haulage of empty wagons on private account, as per the following:

i) when hauled by scheduled goods train	Rs.61.00 only per eight wheeled wagon per kilometer subject to a minimum of Rs.6100/- (Rupees Six Thousand One Hundred only) for all gauges.
ii) when hauled by special train	Rs.1708/- (Rupees One Thousand Seven Hundred Eight only) per kilometer subject to a minimum of Rs.1.70,800/- (Rupees One Lakh Seventy Thousand Eight Hundred only) per train for all gauges.


If the charges at the rate of Rs.61.00 per kilometer for the actual number of wagons hauled by a special train work out higher than the charges at rates indicated in item (ii) above, the former would be leviable. No supplementary charges will be leviable in addition. These rates will also apply to railway wagons given on hire to outside parties for carrying out alteration to suit loading of their over dimensional consignments.

These charges will come into force from 01.02.2012.

This issues with the concurrence of the Finance Directorate of the Ministry of Railways.

Necessary amendment in Rule No. 199(C) of IRCA Goods Tariff No. 41 Pt. I, Vol. I may be done accordingly.
